The creation and organization of the UIA MEDIATION FORUM Prize by the Co-Presidents of the UIA World Forum of Mediation Centres is directly related to the purpose of the UIA World Forum of Mediation Centres.

That purpose is to raise awareness of the utility of mediation in any field, not only amongst current users but also amongst the younger generation and students, offering them the chance to meet with professionals working in mediation, providing the opportunity to enhance practice, and gathering different generations in the UIA MEDIATION FORUM.

The UIA MEDIATION FORUM Prize is awarded to a **student under 30 years of age** in recognition of the **best report presented at and related to the UIA World Forum of Mediation Centres attended**, on the basis of the quality of the report's content.

The reports must be submitted by July 31, 2026 at the latest.

THE REPORT MUST:

- Respect the format described in article 5-3 of the Rules*.
- Be accompanied by a **picture** of the participant, confirmation of name/surname, current full postal address and email, date and place (town and country) of birth, justification of being a student.
- Be accompanied with a separate letter inserting only **two short handwritten sentences** summarizing, in one of the working languages of the UIA (**French, English or Spanish**), the reason(s) why the participant has decided to attend the UIA MEDIATION FORUM and to participate in the UIA contest organized by the Rules. This separate letter, dated and signed by the author, will be scanned and sent with the report by email, as indicated in article 5-4 of the Rules, below.
- Indicate which is the **native language** of the author.

09:30 – 11:00 LANDSCAPE OF MEDIATION IN GREECE

Although the roots of mediation go back to Greek Mythology, mediation as a structured process was not introduced in Greece until 2010, to comply with EU Directive 52/2008. It faced too many obstacles, which led the authorities to make it, in many cases, a mandatory prerequisite before proceeding in Court. Yet the Supreme Court denied the legitimacy of such Law, which consequently had to be withdrawn. A third Law was promulgated in 2019, which followed a middle ground system. Today, mediation has evolved, especially in family law cases, and has expanded to other areas of disputes, such as those involving the State exercising its administrative authority, land disputes and penal cases.

Should only some dispute types get free or discounted mediations? Should the wealth of disputants be calculated and how to do this? If the majority of mediations are free does it stop being a profession and become a pastime? Why should a mediator not be paid when the lawyers are? 17:00 – 18:15 THE MEDIATION 2.0 INNOVATION WITHOUT BORDERS ROUND TABLE

Innovation in mediation is advancing at remarkable speed, with artificial intelligence and other technological advances, mixed modes, litigation funding and new regulatory frameworks reshaping practice worldwide and giving rise to what many now call “Mediation 2.0.”

This round table brings together experienced practitioners, mediation administrators, ADR thought leaders and entrepreneurs to examine some of the most significant developments transforming the international landscape, including (i) advances in artificial intelligence as well as emerging algorithmic tools and (ii) new initiatives such as WIPO’s AI dispute mediation services and the European Union’s recently launched Patent Mediation and Arbitration Centre (PMAC) in Ljubljana and Lisbon.

The panel will also explore regulatory innovation, focusing in particular on the Singapore Convention and the reasons why no EU Member State has yet signed it, despite 59 signatories worldwide (including the non-EU major economic powers: United States, China, India, South Korea, the United Kingdom, Japan, and Brazil), and 19 ratifications, and will consider whether existing instrument – such as the Brussels and Lugano Conventions – or other legal mechanisms may already facilitate the recognition and enforcement of mediated settlement agreements within the EU and EFTA, thus significantly minimizing any practical need for the Singapore mechanisms. In sum, the round table session will highlight how innovation and legal imagination are reshaping mediation practice for the next generation.

Rapid advances in medical science, artificial intelligence and life-sustaining technologies have created complex ethical conflicts within healthcare settings. Disputes arising in hospitals and intensive care units increasingly involve patient autonomy, dignity, informed consent and end-of-life decision-making, extending beyond traditional legal analysis. This session introduces Bioethical Mediation as a very recent and emerging field of mediation practice and defines its scope and relevance for mediators. It examines the specific role and core skills of the bioethical mediator, the types of disputes addressed, and the fundamental differences between bioethical mediation and other mediation models.
